

2017 MANUFACTURER'S CERTIFICATION STATEMENT

Takagi Tankless Water Heaters certifies the following information related to tax credits provided under the Bipartisan Budget Act of 2018.


Each Takagi water heater model listed is a natural gas, propane, or oil water heater that has energy factor of at least 0.82 or has a thermal efficiency of at least 90%. Accordingly, each is Qualified Energy Property and, when placed into service on or after January 1, 2017 and on or before December 31, 2017, each qualifies for the tax credit allowed under Section 25C of the Internal Revenue Code of 10% (up to \$300, subject to limitations set forth in Section 25C) of the purchase and installation (labor only) cost. If you have claimed previous tax credits in excess of \$500, you cannot claim any credit for improvements installed in 2017.
